1 Membership Category

Please select one of the following:

MANUFACTURER MEMBERSHIP

Manufacturer Membership applies to companies engaged in the manufacturing of batch, custom and specialty chemicals, organic and inorganic, in North America (the United States, Canada, and/or Mexico). *Manufacturer Member Companies must show their commitment to performance improvement by completing and signing the ChemStewards® Core Principle Statement (Attachment C).*

INTERNATIONAL MEMBERSHIP

International Membership applies to companies engaged in the manufacturing of batch, custom and specialty chemicals outside of North America, or whose parent or any subsidiary manufactures batch, custom and specialty chemicals outside of North American countries, but which has sales of these chemicals into North American countries.

DISTRIBUTOR MEMBERSHIP

Distributor Membership applies to any company (including their parents and subsidiaries) that does not manufacture batch, custom and specialty chemicals but who resells batch, custom and specialty chemicals in North American countries. Distributor Members cannot have any manufacturing facilities, but may operate repackaging and/or blending operations.

AFFILIATE MEMBERSHIP

Affiliate Membership applies to any company that provides products and services to the chemical industry. Affiliate members do not manufacture or sell chemicals.
